JOB PURPOSE

To assist in delivering the AMIF project in line with the agreed business plan and the requirements of the UKRA who monitor the project delivery on behalf of EU funders. Providing support to local Employment Advisers needing assistance with highly skilled refugee clients looking to resume the profession they practiced overseas in the UK.

PRINCIPAL ACCOUNTABILITIES

- To liaise with local Employment Advisers in the 6 counties of the East of England
 to identify professionally qualified refugees who need advice and guidance to be
 able to find employment that reflects their professional qualifications and their
 English ability.
- To develop advice and guidance materials to explain the routes to requalification needed for the ten most common professions refugees present with, including details of funding sources for refugee students. To share these resources with the local employment advisers and other relevant regional and national networks.
- 3. To recruit and manage professional mentors to provide one to one advice for individual beneficiaries on their journey to employment.
- 4. To work with regional ESOL Coordinator to recommend suitable ESOL courses for beneficiaries as required.
- 5. To work with Job Centres, the AMIF Employer Liaison Officer and other relevant partners to find interim work opportunities (paid or voluntary, of any duration) to



improve beneficiaries' CVs whilst they work on improving their English or other Skills.

- 6. To contribute to monthly report AMIF Project and Employment Adviser meetings to report on outcomes.
- 7. Such other similar policy/research/communications activities as may from time to time be required
